IMPORTANT INFORMATION from the Physician Surgery Center of Albuquerque

history of any medical issue listed below**

Cardiac

- a. Heart stents
- b. Heart attack
- c. Coronary artery bypass graft surgery (CABG/bypass)
- d. Atrial Fibrillation (A-fib)
- e. Ablations
- f. Aortic aneurysms
- g. Coronary artery disease (CAD) with moderate- severe blockages
- h. Pacemaker/Implantable cardioverter defibrillator (ICD)
- i. Valve replacements
- j. Congestive heart failure (CHF)
- k. Holter monitor
- l. Newly diagnosed heart murmur/irregular heart rhythms
- m. Uncontrolled hypertension

Pulmonary

- a. Shortness of breath at rest
- b. Tumors that impair breathing
- c. Above 3L of oxygen if worn 24/7
- d. Pulmonary embolisms

Other

- a. Newly diagnosed blood clots
- b. Strokes with deficits
- c. Tuberculosis
- d. Newly diagnosed seizure disorder
- e. Aneurysms
- f. If undergoing cancer treatment
- g. Uncontrolled diabetes
